Decarbonising our pension investments

We've taken proactive steps to re-shape Oxfordshire pension funds. The aim is to maximise investment returns and better contribute to our strategic objectives to create a greener, healthier and fairer county. At its meeting earlier in June, the Pension Fund Committee agreed to reduce its allocation to the UK market and in particular to the FTSE100 companies that have links to major oil, gas and and mining companies. The committee also chose to end investments in emerging markets reflecting concerns about social and governance issues – specifically within China and Saudi Arabia.

The Oxfordshire part of the Local Government Pension Scheme is overseen by the Pension Fund Committee, which is hosted by us at the county council. It also represents the district and city councils and other public sector organisations, including Oxford Brookes University, academy schools, further education colleges and housing associations.

Broad Street, Oxford

The Broad Street project aims to transform Broad Street's historic highway into an accessible and welcoming space for everyone to enjoy, and is delivered under an Experimental Traffic Regulation Order and will provisionally be in place until spring 2024. Council Future Governance

I am taking part in a committee which is looking at whether OCC should operate under the present cabinet system, or adopt a committee system which could involve a wider range of members in decision-making.

We'll also be looking at how participatory democracy (such as citizens' juries/assemblies) could be used to make the council more open to its residents and improve decision making.

County Council's City Centre properties

I'm also part of a group which is helping to advise on what the council should do with its various city centre properties, including New County Hall, which is in need of major refurbishment, with a view to making better use of space given the way workplaces have changed since the pandemic, while keeping the democratic process accessible to all.

Culham / Clifton Hampden & Burcot: HIF1 planning application:

The plans for the road(s) and bridge linking the A34 Milton interchange to Golden Balls roundabout finally came to the OCC planning and regulation committee on July 17th and 18th. After over 10 hours of discussion and speakers, the committee decided to reject the detailed application for a number of reasons, including the traffic impact on Nuneham Courtenay/Golden Balls, and compliance with the county council's own LTCP and climate policies. There has been a subsequent letter from the Secretary of State for Levelling Up, Communities and Housing saying he is minded to hold an inquiry into the application. We await dates for this and thus next steps and impacts are unclear at this time.

Dorchester/Shillingford:

Tragically, a cyclist was killed in a collision on Tuesday 4th July close to the junction with Henley Road towards Dorchester. Police are investigating. I have previously asked for this stretch of the A4074 to be made safer for all road users, and will continue to press for this.

Nuneham Courtenay:

20mph proposal out to consultation soon. This will swap the existing 30mph stretch to 20.

Berinsfield/Dorchester:

Some improvements will be made this summer to the informal crossing point of the A4074 which connects to the old Oxford Road path into Dorchester opposite Clovers. The area will be all scraped back of debris and have 6 bollards installed (along with 'cycles crossing warning signs on the vehicular approaches).

Appendix B – Report from District Councillor

South Oxfordshire District Councillor's Monthly Report for July 2023 (Chalgrove Ward)

Garden waste fly-tip is a costly mistake. A man has been ordered to pay more than £1,400 after garden waste was found dumped near Great Haseley in South Oxfordshire. Karl Horwood, 60, of Bletchingdon, Oxfordshire, appeared at Oxford Magistrates' Court on Friday 16 June when he admitted failing in his duty of care for waste disposal. Mr Horwood had been arrested a week earlier on suspicion of breaching the Environment Act 1990 after he had failed to respond to requests from South Oxfordshire District Council Environmental Enforcement Officers for assistance with their enquiries about the incident. Magistrates heard how, in January 2022, Mr Horwood had carried out work at a property in Great Haseley and had been paid £150 to remove four bulk bags full of garden waste. However, he failed to ensure that the waste was disposed of properly and it was then found dumped on the side of the road along the A329.

Ukrainian housing officer Olha now helping others find their feet.

Supporting Refugee Week, Olha, who works as part of South Oxfordshire and Vale of White Horse district councils' Ukraine Support, shares her experience leaving Ukraine, arriving in the UK, finding work and accommodation, and settling in her family to life in the UK. Olha arrived in the UK in May 2022 and came to the country under the Homes for Ukraine scheme. As a Housing Support Officer, Ohla is now helping others in the same situation find their feet and secure accommodation. "As with many other Ukrainian people at beginning of spring 2022, I had to make a very hard decision and leave behind our well-settled life and my job as a lawyer and flee from the war. In a desperate search of a safe place for my children, I got to know about the Homes for Ukraine programme announced by the British Government. I arrived in Oxfordshire with my two daughters in May 2022, as a guest under the Homes for Ukraine scheme. We have had the most wonderful hosts Jayne and John who have been very helpful and supportive in the most challenging times of our life. Our hosts introduced us to their wider family and friends, took us out, drove to see the sights and much more. After things got a bit settled, I started volunteering in local meetings for Ukrainians and then got a temporary job in a summer language school which was wonderful. As a mother of two children, I can only guess how all the stress has already influenced and still will impact my children, but I choose to stick to the words of another amazing couple Joanna and Neal who also provided us with incredible support. Once they said to me that all this is character-building for my children, and it is up to me in what colours to present the situation and what lessons to take out. So, I choose to show them that the human relationship is one of the main values in our life and how it is important to be sincere, open and ready to help others."

Latest images unveiled for proposed new council HQ.

A new building that will kickstart the revitalisation of Didcot Gateway is now one step closer, with updated images of the proposed new council headquarters having been released. A formal planning application is expected soon. The building will be the first step to bring new life into this historically neglected site, providing more confidence for future business investment and making Didcot an even more attractive place to live, work and learn. Inspired by green living principles of the Didcot Garden Town vision, the building is set to be both eye-catching and eco-friendly with striking living walls of climbing plants to welcome visitors

arriving from the train and bus station. Homes England will also be developing a larger section of the Gateway site for housing in due course. The designs show a four-storey building themed around the town's railway heritage, which also incorporates high standards for sustainability by building with environmentally friendly materials, using design principles to reduce energy use, and using renewable energy sources where possible. As well as offices for council staff, there will be flexible space for commercial rent and public areas such as a café and landscaped gardens. Both South Oxfordshire and neighbouring Vale of White Horse District Council plan to call the office home, as it will provide a flexible, sustainable workspace central to the two districts and help them become carbon neutral councils whilst earning SODC the much-needed revenue. SODC owns the site and if it goes ahead will be charging the Vale of White Horse a rent for its use of the building. A final decision on the old Crowmarsh SODC owned site is yet to be made.

Wallingford and Henley looking to secure bathing water status.

Organisations across South Oxfordshire are planning to apply for bathing water status on the River Thames at Wallingford and Henley, which, if awarded, should result in a safer, less polluted environment for swimmers, river users and wildlife. In Wallingford, South Oxfordshire District Council is aiming to work with Wallingford Town Council to make a joint application to the government department responsible for granting bathing water status – the Department for Environment, Food and Rural Affairs (Defra). It is also supporting a bid for bathing water status being made by Henley Town Council. Both applications will be supported by environmental charity Thames21. Thames21 will use data gathered from the 2023 bathing season in the applications. This will include the numbers of those using the river as well as water samples taken by Thames21 and local trained volunteers. Thames21 plan to publicise the water quality data on an online story map on their website during the bathing season. If bathing water status is awarded, Thames Water would be legally required to treat waste outflows to a much higher standard, meaning they could not release water into the river without ensuring the removal of bacteria which is harmful to the health of people and wildlife. It would also mean that during the bathing season, from May to September each year, the Environment Agency would be required to monitor the water quality and publicise the results.
